The Healthcare Technology short term technical certificate recognizes the student who has completed a core group of healthcare courses.

This certificate provides the most basic training needed to employ the student in most entry level healthcare roles. This certificate program is also in alignment with a ladder pathway towards most Associate degree programs in Allied Health, in which it meets most prerequisite requirements to apply and matriculate into currently approved applied associate degrees. In addition, the Health Technology certificate program aligns Ohio Department of Education Industry Recognized Credentials: Patient Care Technician and Electronic Health Records certification examinations. Lorain County Community College has articulation agreements with colleges and universities including programs offered by Lorain County Community College's University Partnership.
