## Excused Absences for Religious Holidays and Observances

Under the Testing Your Faith Act (https://www.lorainccc.edu/policies/ excused-absences-for-religious-holidays-and-observances/) adopted by the State of Ohio, students may have up to three excused absences each semester from their courses to observe religious holidays in accordance with their spiritual beliefs. All LCCC instructors must provide alternative accommodations for examinations or other academic requirements as a result of one of these excused absences. To be eligible for an excused absence and to receive alternative accommodations in their courses, students must provide their instructors with written notice of the specific dates for which they are requesting alternative accommodations no later than fourteen days after the first day of instruction for their courses. Any alternative accommodation offered by an instructor must not have a detrimental impact on a student's ability to complete their course requirements. Under the Testing Your Faith Act, instructors must accept without question the sincerity of a student's religious or spiritual beliefs, and all requests shall be kept confidential.
